### KEY PRINCIPLES

We have always been committed to providing our services with the highest degree of quality, which includes treating your data with security and transparency. Our principles are:

- **Legality:** We will only collect your personal data for specific, explicit and legitimate purposes.
- **Data minimization:** We limit the collection of personal data to what is strictly relevant and necessary for the purposes for which it was collected.
- **Limitation of the Purpose:** We will only collect your personal data for the declared purposes and only according to your wishes.
- **Accuracy:** We will keep your personal data accurate and up-to-date.
- **Data Security:** We apply technical and organizational measures appropriate and proportional to the risks to ensure that your data does not suffer damage, such as disclosure or unauthorized access, accidental or unlawful destruction or accidental loss or alteration and any other form of illicit treatment.

- **Access and Rectification:** We have the means to access or rectify your data when it deems appropriate.
- **Conservation:** We keep your personal data in a legal and appropriate manner and only if it is necessary for the purposes for which they were collected.
- **International transfers:** when it happens that your data will be transferred outside the EU / EEA, they will be adequately protected.
- **Third parties:** The access and transfer of personal data to third parties are carried out in accordance with applicable laws and regulations and with adequate contractual guarantees.
- **Direct Marketing and cookies:** We comply with the applicable legislation regarding advertising and cookies.

## **COLLECTION AND PROCESSING OF YOUR PERSONAL DATA**

The types of data that are requested and processed are:

- Identification data

Whenever we request your personal data, we will inform you with the clarity of what personal data we collect and for what purpose. In general, we collect and process your personal data to:

- Provide information about our products and services.
- Respond to your queries and requests.

## **LEGITIMACY**

In accordance with the applicable data protection regulations, your personal data may be processed if:

- You have given your consent for the purposes of the treatment. Of course, you can withdraw your consent at any time.
- It is necessary for the provision of any of our services through a contractual relationship between you and us.
- With such treatment, we seek a legitimate interest that is not impaired by your privacy rights. Such legitimate interest will be duly communicated to you in the privacy notice related to that treatment.
- It is required by law

## **COMMUNICATION OF PERSONAL DATA**

During the period of duration of the treatment, the company will not make any assignment, except for legal obligation.

## **YOUR RIGHTS**

In relation to the collection and processing of your personal data, you can contact us at any time to:

- Rectify your personal data that is inaccurate or incomplete according to Article 16 of the RGPD.
- Delete your personal data in accordance with Article 17 of the RGPD.
- Limit the processing of your personal data in accordance with Article 18 of the RGPD.
- Request the portability of your data in accordance with Article 20 of the RGPD.
- Oppose the processing of your personal data in accordance with article 21 of the RGPD.

If you have given your consent for a specific purpose, you have the right to withdraw the consent granted at any time, without affecting the legality of the treatment based on the consent prior to its withdrawal.
